## **RELEVANT FACT**

## Dear Sir,

In accordance with Law 24/1988, 28th July, relative to the regulation of the stock market and related provisions, LABORATORIO REIG JOFRE SA ("Reig Jofre" or "the Company") informs that on December 23, 2015 Reig Jofre signed a liquidity contract with SOLVENTIS AV SA according to the provisions of Circular 3/2007 of December 19, of the Spanish Stock Exchange Commission (CNMV), for the purposes of its acceptance as a market practice and within the limits of the authorization granted by the Company's General Shareholders' Meeting.

The new liquidity contract substitutes the previous one, signed on February 11, 2015 with GVC GAESCO VALORES SV SA.

The new contract details are:

- Entry into force: January 1, 2016
- Validity: 18 months, from the date of its signature and understood as tacitly extended for the same period, unless otherwise specified by the parties.
- Transactions will be carried out in the Spanish electronic market (Mercado Continuo)
- Shares in the securities account on 31/12/2015: 236,825 shares <sup>(1)</sup>
- Cash in the cash account on 31/12/2015: 939,386.41 euro
